


## **1 PRODUCT INTRODUCTION**

Baby Sleep Tracking Pad


Please read this user manual carefully before using the product, and keep this user manual properly.

1.1 What's in the box

- Baby Sleep Tracking Pad
- Bluetooth gateway
- Micro USB cable
- Power adapter (5V, 1A)
- User manual









## 2 HOW TO USE THE DEVICES

**1.** Plug the Bluetooth gateway into the power socket, then the device is powered-on when the indicator light is on.



**2.** After the Baby Sleep Tracking Pad is fully charged, long press the power button for 3s, the device is powered-on when the green indicator light is on.





**3.** Place the Baby Sleep Tracking Pad under the mattress at baby's chest position (Notice: mattress thickness shall be between 3 to 5 cm)



**4.** Open Maxi-Cosi Smart APP to add the Bluetooth gateway and the Baby Sleep Tracking Pad as the APP prompts.



## 3 HOW TO USE THE APP

3.1 How to use the application

**1. Installation** Search Maxi-Cosi Smart APP on your smarphone in App Store / Google Play

**2. Sign Up & Log In** Open Maxi-Cosi Smart APP, sign up and log in your account as the App prompts.

**3. Add Devices** Power on the Baby Sleep Tracking Pad and Bluetooth gateway, then turn on the Bluetooth on your smartphone and open Maxi-Cosi Smart APP. Finally, add the devices as the APP prompts.

**4. Start Sleep Monitoring** Both the Baby Sleep Tracking Pad and Bluetooth gateway are automonitoring devices. They will start to monitor the baby's sleeping status automatically when powered-on, therefore no manual interventions required.

**5. Sleep Report** Click "Report" icon in the APP to check on the baby's sleep report.



**6.** To get live data from the Maxi-Cosi Smart APP you need to be connected to the Bluetooth (if you are less than 10 meters away from the tracking device) or to the house WIFI when out of the baby room.

# 4 HOW TO USE THE DEVICES

4.1 Audible Alarm

**1.** The Baby Sleep Tracking Pad will issue a buzzer alarm in case of unusual breathing rate.

**2.** You will receive a pop-up alarm on your phone if it is connected to the Wifi or Bluetooth.

**3.** Press the power button of the Baby Sleep Tracking Pad to turn off the alarm.

4.2 Battery Life

**1.** When battery is fully charged, the Maxi-Cosi e-Snooze will last turned on for 15 consecutive days.

**2.** When the battery runs out, you may fully charge the Maxi-Cosi e-Snooze again.
